

**RESOLUTION No: 2007-07**

**RESOLUTION AUTHORIZING PERMANENT DIVESTITURE OF AND  
TRANSFER TO THE CITY COUNCIL OF THE CITY OF HOLLISTER, THE  
ENTIRE TWENTY FIVE UNITS OF SECTION 8 HOUSING CHOICE VOUCHER  
ASSISTANCE IN CONSOLIDATED ANNUAL CONTRIBUTIONS CONTRACT  
(CACC) SF 1880**

**WHEREAS**, the total housing choice voucher (Section 8) allocation for the City of San Juan Bautista is 25 Vouchers; and

**WHEREAS**, as a result of diminishing funding allocations, administration of a minimally sized Section 8 Housing Choice Vouchers is infeasible; and

**WHEREAS**, the availability of rental stock within the City of San Juan Bautista is limited; and

**WHEREAS**, the City Council of the City of San Juan Bautista recognizes that by transferring the 25 Vouchers in CACC SF 1880 to the Housing Authority of the City of Hollister, the 25 San Juan Bautista Vouchers will become part of a larger Hollister Voucher (Section 8) Program; and

**WHEREAS**, the City Council of the City of San Juan Bautista wishes to provide the widest possible choice for all Voucher holders seeking rental housing; and

**WHEREAS**, the City Council of the City of San Juan Bautista also wishes to allow Vouchers issued by the Housing Authority of the City of Hollister to be used within the jurisdiction of the City of San Juan Bautista.

**NOW THEREFORE BE IT RESOLVED**, that effective July 1, 2007, the City Council of the City of San Juan Bautista hereby permanently divests and transfers the 25 (twenty-five) Housing Choice Vouchers in CACC SF 1880 to the Housing Authority of the City of Hollister; and

**BE IT FURTHER RESOLVED**, that all Vouchers, whether issued by the City of San Juan Bautista or the Housing Authority of the City of Hollister, may be used in the jurisdiction of the City of San Juan Bautista.

This resolution is effective only upon approval, by the United States Department of Housing and Urban Development (HUD), of the request for transfer and permanent divestiture of the 25 Housing Choice Vouchers CACC SF 1880 by the City Council of the City of San Juan Bautista.
