

**ORDINANCE NO. 2013-01**

**AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF SAN JUAN BAUTISTA AMENDING SECTION 3-5-150 OF THE SAN JUAN MUNICIPAL CODE, WASTE WATER SEWER RATES**

**WHEREAS**, the City has completed a study and analysis of the sewer rates for small commercial shops with limited sanitary sewer facilities, and

**WHEREAS**, on the basis of the study and analysis of the discharge of sanitary effluent from the small commercial shops with limited sanitary sewer plumbing fixtures and number of employee, the waste water sewer rate should be proportional to the quality of sewer effluent discharge into and treated at the waste water treatment facility, and

**WHEREAS**, the City Council has reviewed the analysis and report for sanitary sewerage discharge of small commercial shops within the downtown area which have limited sanitary plumbing fixtures and a small number of fulltime employees and concluded that the waste water sewer rates need to be based upon a relationship to the quantity of discharge and the cost to provide treatment of the waste water effluent.

**NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF SAN JUAN BAUTISTA HEREBY ORDAINS AS FOLLOWS:**

**SECTION 1.** Section 3-5-150 of the San Juan Bautista Municipal Code is hereby amended as follows:

**WASTE WATER RATES:**

Customer Classification	Monthly Sewer Rates
Residential	\$74.37
Commercial	\$74.37
Standard Strength	\$8.05 / 1000 gallons
Moderate Strength	\$12.06 / 1000 gallons
High Strength	\$16.09 / 1000 gallons
Septage	\$40.23 / 1000 gallons
Small Business w/ limited fixture units & Less than four employees	\$ 47.85
Small Business w/ limited fixture units & More that five employees	\$ 57.85

**SECTION 2. SEVERABILITY:**

This ordinance and the various parts thereof are hereby declared to be severable. Should any section of the ordinance be declared by a court to be unconstitutional or invalid, such decisions shall not affect the validity of the ordinance as a whole, or any parts thereof, so declared to be unconstitutional or invalid.

**SECTION 3. EFFECTIVE DATE:**

This ordinance shall go into effect thirty (30) days after the date of its adoption.
