

RESOLUTION NO. 2013-15

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF
SAN JUAN BAUTISTA SETTING PARKING FINES
PURSUANT TO SAN JUAN BAUTISTA MUNICIPAL
CODE SECTION 7-4-700**

WHEREAS, Section 7-4-700 provides that the Council may, by resolution, adopt fines for violation of, among other regulations, parking regulations, and;

WHEREAS, pursuant to Resolution No. 2012-51, this Council previously set parking fines, and has now determined that the fine schedule set by said resolution should be changed to reflect increased enforcement costs; and

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF SAN JUAN BAUTISTA HEREBY RESOLVES AS FOLLOWS:

SECTION 1. A violation of the following San Juan Bautista Municipal Code parking regulations, listed by Municipal Code Section numbers, shall be punishable by a fine of Sixty-five dollars (\$65.00):

- 7-4-105 Unauthorized standing or loading
- 7-4-100 Stopping in specified places
- 7-4-105(A) Exceeding Loading Time
- 7-4-115(A) Parking with right wheels farther than 18" from curb
- 7-4-120 Parking vehicle on streets for purpose of sale
- 7-4-130 Parking and storage of boats
- 7-4-135 Parking on private property without owner's consent
- 7-4-140 Parking or standing to sell from vehicle; vendor permit required
- 7-4-140 Selling from parked vehicle
- 7-4-205 No parking – yellow zone – 30 minutes
- 7-4-210 Exceeding loading time -- white zone -- 10 minutes
- 7-4-215 Exceeding parking time -- green zone -- 15 minutes
- 7-4-515 Parking on city streets for repairs
- 7-4-710 Parking in excess of 72 hours

SECTION 2. A violation of San Juan Bautista Municipal Code Section 7-4-715 (Parking of oversized vehicles) shall be punishable by a fine of One Hundred Sixty-five dollars (\$165.00).

SECTION 3. A violation of San Juan Bautista Municipal Code Section 7-4-420 (Restricted parking – handicap zone) shall be punishable by a fine of Two Hundred Ninety dollars (\$290.00).

SECTION 4. Additional assessments for failure to timely pay the fines set out hereinabove shall be as provided in Chapter 2-7 of the San Juan Bautista Municipal Code.
