**RESOLUTION OF THE CITY COUNCIL OF THE CITY OF
SAN JUAN BAUTISTA DECLARING THE RESULTS OF THE
GENERAL MUNICIPAL ELECTION HELD ON TUESDAY,
NOVEMBER 8, 2016**

WHEREAS, by Resolution No. 2016-27, adopted at a regular meeting of the San Juan Bautista City Council on May 17, 2016, this Council called and set the 2016 General Municipal Election to be consolidated with the Statewide General Election to be held the same day, on November 8, 2016; and

WHEREAS, by Resolution No. 2016-27 this Council placed on the municipal election ballot the election of two (2) members of the City Council to succeed those members whose terms end;

WHEREAS, City has received and this Council has reviewed the official election results compiled by the County of San Benito, copy attached hereto; and

WHEREAS, this is the time and place for the Council to meet and proceed to declare the results of the 2016 General Municipal Election;

**NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF SAN
JUAN BAUTISTA HEREBY RESOLVES AS FOLLOWS:**

SECTION 1. The candidates for the two (2) available Council seats and the number of votes cast for those candidates are as follows:
